WATER DEPOSIT & TERMINATION OF SERVICE

Should a property owner or tenant vacate premises please promptly notify Cherokee Village Waterworks to collect your \$100.00 deposit. All final water bills & fees must be paid in full before a deposit will be refunded. Deposits from property owners are still held for security when a homeowner turns the property into a rental. If property owner chooses to have water bill sent directly to the tenant a deposit will be collected from the tenant. (Homeowner are responsible for any unpaid balance over the \$100.00 deposit paid by their tenants) Deposit refund checks not cashed within 6 months will be void. Deposits not claimed within a year are sent to the State and must be collected from the State. Termination of service must be in writing.

UTILITY RELEASE

I hereby authorize any utility company (electric, gas, water, sewer, etc.) to supply upon request to Cherokee Village Waterworks all pertinent information concerning the above listed address and individuals. This information may be needed to verify and confirm information supplied by the above tenants. **A picture I.D. is required** before service can be connected.

I certify that the above information is correct and I also verify that I do not owe any outstanding water or sewer bills to Cherokee Village Waterworks or other utility company. I realize that any incorrect or misrepresented information could be considered fraud and could result in subsequent disconnection of water service.

LATE FEES

If bill is paid after due date a 10 percent late fee is applied to bill (Gross Bill). A bill is considered delinquent 10 days after the due date. If the bill has not been paid or arrangements made in advance, water service could be discontinued until the bill is paid in full including reconnect fees. **We do not send out late/shutoff notices. Failure to receive bills in no way exempts customer from payment of bill. For your convenience we offer automatic bank draft.**
